

ORDINANCE NO. 890 C.S.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MADERA, CALIFORNIA AMENDING CHAPTER 1 OF TITLE II OF THE MADERA MUNICIPAL CODE, REPEALING EXHIBIT A AND ADDING A NEW EXHIBIT A PERTAINING TO COUNCIL DISTRICT BOUNDARIES

SECTION 1. Chapter 1 of Title II of the Madera Municipal Code is hereby amended by repealing Exhibit A in its entirety and adding a new Exhibit A as attached.

SECTION 2. If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council declares that it would have adopted this ordinance, and each and every section, subsection, sentence, clause, or phrase not declared invalid or unconstitutional, without regard to whether any portion of the ordinance would be subsequently declared invalid or unconstitutional.

SECTION 3. This ordinance shall take effect thirty (30) days after its passage by the City Council.

The foregoing Ordinance No. 890 C.S. was introduced and given its first reading at a regular meeting of the City Council of the City of Madera held on the 5th day of October, 2011 and adopted after a second reading at a regular meeting of the City Council held on the 19th day of October, 2011 by the following vote:



Madera 2011 Plan 1

Street by Street Description

District 1

Starting at the intersection of Sunset Avenue and Road 24, proceed easterly along Sunset Avenue, then south on Mainberry Drive, then east on Lansing Street, then south on Sassafras Drive, then west on the service road north of Howard Road, then south on Mainberry Drive to Howard Road, then east on Howard Road, which becomes Olive Avenue, until N Street. Continue northwest on N Street until Sunset Avenue, then west on Sunset Avenue, then north on Willis Avenue, then west on University to Schnoor Avenue. Continue north on Schnoor Avenue to Cleveland Avenue, then west on Cleveland Avenue, then north on Granada Drive, then east on Foxglove way, then north on Schnoor Avenue to Kennedy Street. Continue west on Kennedy Street to Highway 99, and continue across Highway 99 northeasterly to the border of the City, and then northerly, westerly, and southerly around the border of the City of Madera to the place of origin.

District 2

Starting at the intersection of Sunset Avenue and Road 24, proceed easterly along Sunset Avenue, then south on Mainberry Drive, then east on Lansing Street, then south on Sassafras Drive, then west on the service road north of Howard Road, then south on Mainberry Drive to Howard Road, then east on Howard Road, which becomes Olive Avenue, until Martin Street. Proceed south on Martin Street, then east on Lewis Street, until Madera Avenue (California Route 145). Then continue south on Madera Avenue until the border of the City of Madera. Continue southerly, westerly, and northerly around the border of the City of Madera to the point of origin. This district also contains the non-contiguous parcel of the City of Madera west of the City proper, containing the City Waste Water Treatment Plant.

District 3

Starting at the extension of Kennedy Street across Highway 99, follow Avenue 16 westerly until Schnoor Avenue, then proceed south on Schnoor Avenue, then west on Foxglove way, then south on Granada Drive, then east on Cleveland Avenue until Schnoor Avenue. Continue south on Schnoor Avenue, then east on University Avenue, then south on Willis Avenue, then east on Roberts Avenue, north on Pine St, and again east on Roberts Avenue, then northeast between parcels 006-190-048 and 006-190-049, to Highway 99. Follow Highway 99 north until the Fresno River, then follow the Fresno River easterly until Lake Street. Continue north on Lake Street, then west on Green Way, then north on Austin Street until the border of the City of Madera. Continue westerly along the northern border of the City of Madera to the point of origin.

District 4

Starting at the City border north of the intersection of Barcelona Way and Segovia Way, follow the City border east, then south between parcels 005-241-040 and 005-241-041, then south on San Sebastian Way, then east on Laguna Way to Raymond Road. Continue southwesterly on Raymond Road, then southeasterly on Tozer Street, then southwesterly along the Fresno River to Lake Street. Continue north on Lake Street, then west on Green Way, then north on Austin Street until the border of the City of Madera. Continue northerly, easterly, and southerly along the border of the City of Madera to the point of origin.

Street by Street Description**District 5**

Starting at the City border north of the corner of Barcelona Way and Segovia Way, follow the City border east, then south between parcels 005-241-040 and 005-241-041, then south on San Sebastian Way, then east on Laguna Way to Raymond Road. Continue southwesterly on Raymond Road, then southeasterly on Tozer Street, then southwesterly along the Fresno River to Highway 99. Continue southeasterly along Highway 99, then southwest between parcels 006-190-048 and 006-190-049 to Roberts Avenue, then west on Roberts Avenue, South on Pine Street, then west on Roberts Avenue again, then south on Willis Avenue, then east on Sunset Avenue to N Street. Proceed southeast on N Street, then northeast on 3rd Street, then southeast on Highway 99, then northeast on Yosemite Avenue, then southeast on A Street. Continue on A Street as it proceeds east to the City limit. Continue northerly, easterly and westerly along the City limit until the point of origin.

District 6

Starting at the intersection of Avenue 13 and Madera Avenue (also known as Highway 145), proceed north on Madera Avenue to Lewis Street, then west on Lewis Street, then north on Martin Street, then west on Olive Avenue to N Street. Proceed northwest on N Street, then northeast on 3rd Street, then southeast on Highway 99, then northeast on Yosemite Avenue, then southeast on A Street. Continue on A Street as it proceeds east to the City limit. Continue easterly, southerly, and westerly to the point of origin.
