District 1:


Beginning at the intersection of the City's western border and Overland Rd approximately 235 feet west of Honeybell St; thence proceeding easterly along Overland Rd to San Miguel St; thence proceeding northerly along San Miguel St to La Purisma St; thence proceeding easterly along La Purisma St to San Luis Obispo St; thence proceeding northerly along San Luis Obispo St to San Diego St; thence proceeding westerly along San Diego St to the parcel boundary between parcel 424143004000 (1512 San Diego St) and parcel 424143005000 (1516 San Diego St); thence proceeding northerly along that parcel boundary and the parcel boundary between parcel 424115004000 (1513 Greenwich Dr) and parcel 424115005000 (1517 Greenwich Dr); thence proceeding northerly across Greenwich Dr to the parcel boundary between parcel 424114009000 (1518 Greenwich Dr) and parcel 424114010000 (1522 Greenwich Dr); thence proceeding northerly along that parcel boundary and the parcel boundary between parcel 424114016000 (1523 Sherwood Ct) and parcel 424114010000 (1522 Greenwich Dr); thence proceeding northerly along that parcel boundary and the parcel boundary between parcel 424114015000 (1519 Sherwood Ct) and parcel 424114014000 (513 Stonehaven Dr); thence proceeding northerly across Stonehaven Dr and along the parcel boundary between parcel 424116011000 (516 Stonehaven Dr) and parcel 424116012000 (514 Stonehave Dr); thence proceeding northerly along that parcel boundary and the parcel boundary between parcel 424116005000 (1535 Regency Dr) and parcel 424116004000 (1537 Regency Dr) to Regency Dr; thence proceeding northwesterly along Regency Dr to Rockport Dr; thence proceeding northeasterly along Rockport Dr to Westminster Way; thence proceeding northerly along Westminster Way to the southern edge of parcel 424010002000 (17490 Holland Rd); thence proceeding easterly along the southern edge of parcel 424010002000 (17490 Holland Rd) to the intersection of the City border and San Luis Canal; thence proceeding counter-clockwise along the City border to the point of origin.

District 2:

Beginning at the intersection of the City's southern border and Highway 165; thence proceeding northerly along Highway 165 to E Pacheco Blvd; thence proceeding easterly along E Pacheco Blvd to Nickel St; thence proceeding northerly along Nickel St to San Luis St; thence proceeding westerly along San Luis St to Place Rd; thence proceeding northerly along Place Rd to East B St; thence proceeding westerly along East B St to Wisteria Ave; thence proceeding northwesterly along Wisteria Ave to E Wilmott Rd; thence proceeding westerly along E Wilmott Rd to Highway 165; thence proceeding northerly along Highway 165 to Overland Rd; thence proceeding easterly along Overland Rd to San Miguel St; thence proceeding northerly along San Miguel St to La Purisma St; thence proceeding easterly along La Purisma St to San Luis Obispo St; thence proceeding northerly along San Luis Obispo St to San Diego St; thence proceeding westerly along San Diego St to the parcel boundary between parcel 424143004000 (1512 San Diego St) and parcel 424143005000 (1516 San Diego St); thence proceeding northerly along that parcel boundary and the parcel boundary between parcel 424115004000 (1513 Greenwich Dr) and parcel 424115005000 (1517 Greenwich Dr); thence proceeding northerly across Greenwich Dr to the parcel boundary between parcel 424114009000 (1518 Greenwich Dr) and parcel 424114010000 (1522 Greenwich Dr); thence proceeding northerly along that parcel boundary and the parcel boundary between parcel 424114016000 (1523 Sherwood Ct) and parcel 424114010000 (1522 Greenwich Dr); thence proceeding northerly along that parcel boundary and the parcel boundary between parcel 424114015000 (1519 Sherwood Ct) and parcel 424114014000 (513 Stonehaven Dr); thence proceeding northerly across Stonehaven Dr and along the parcel boundary between parcel 424116011000 (516 Stonehaven Dr) and parcel 424116012000 (514 Stonehave Dr); thence proceeding northerly along that parcel boundary and the parcel boundary between parcel 424116005000 (1535 Regency Dr) and parcel 424116004000 (1537 Regency Dr) to Regency Dr; thence proceeding northwesterly along Regency Dr to Rockport Dr; thence proceeding northeasterly along Rockport Dr to Westminster Way; thence proceeding northerly along Westminster Way to the southern edge of parcel 424010002000 (17490 Holland Rd); thence proceeding easterly along the southern edge of parcel 424010002000 (17490 Holland Rd) to the intersection of the City border and San Luis Canal; thence proceeding clockwise along the City border to the point of origin.

District 3:

Beginning at the intersection of the City's southern border and Highway 165; thence proceeding northerly along Highway 165 to E Pacheco Blvd; thence proceeding easterly along E Pacheco Blvd to Nickel St; thence proceeding northerly along Nickel St to San Luis St; thence proceeding westerly along San Luis St to Place Rd; thence proceeding northerly along Place Rd to East B St; thence proceeding westerly along East B St to Wisteria Ave; thence proceeding northwesterly along Wisteria Ave to E Wilmott Rd; thence proceeding westerly along E Wilmott Rd to Highway 165; thence proceeding northerly along Highway 165 to Overland Rd; thence proceeding westerly along Overland Rd to North St; thence proceeding southerly along North St to Willmott Rd; thence proceeding westerly along Willmott Rd to 2nd St; thence
