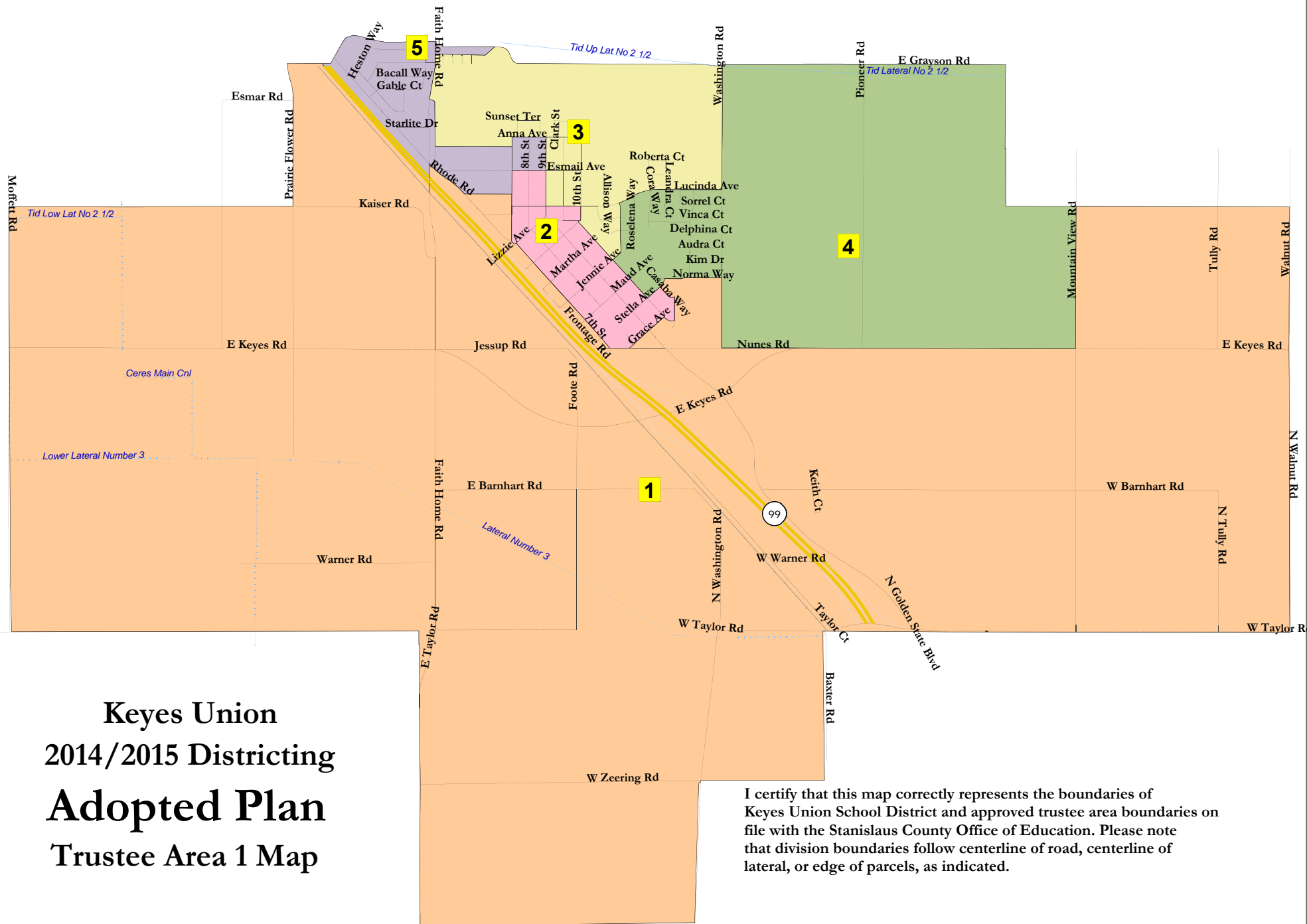

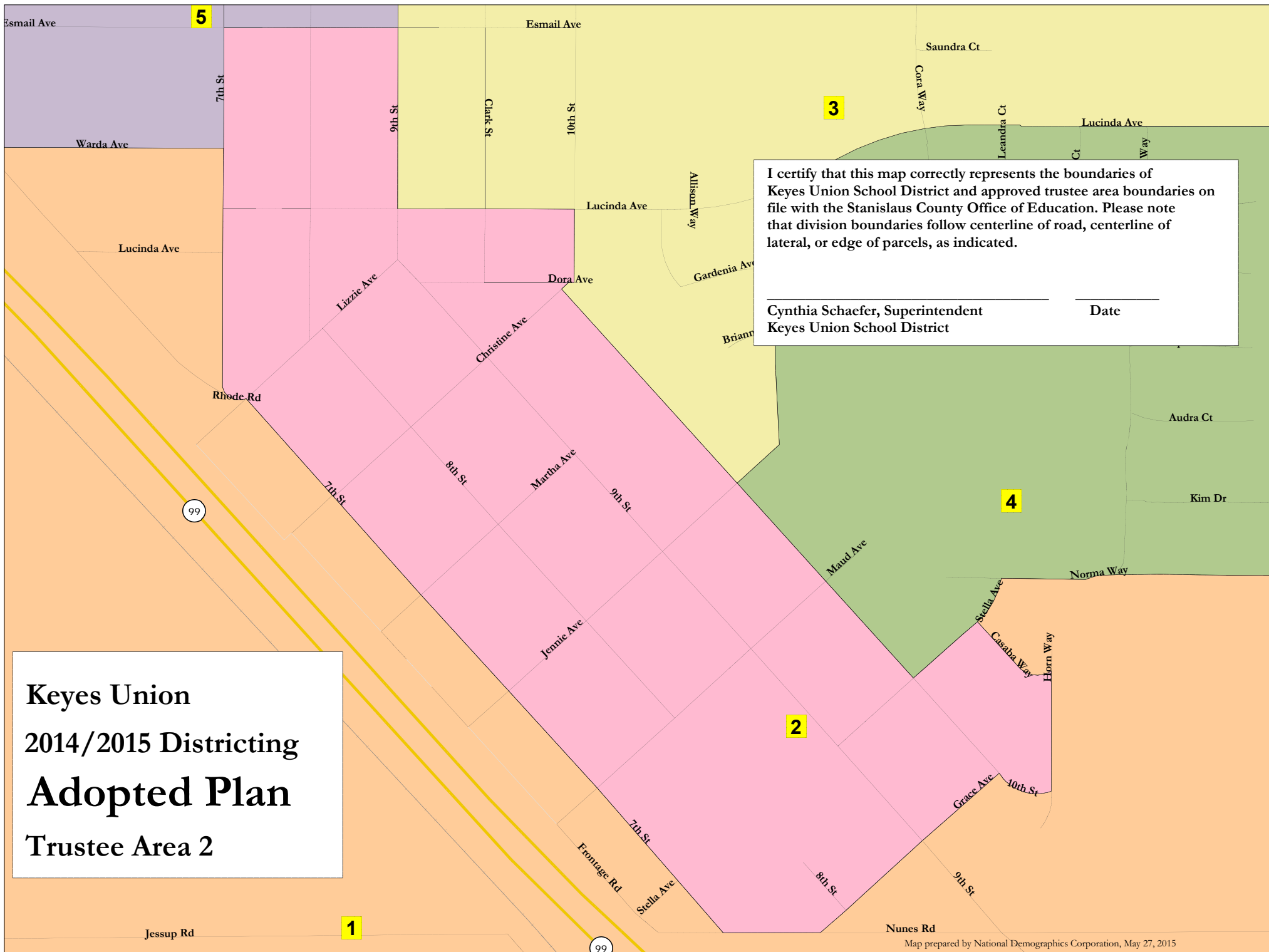


Keyes Union 2014/2015 Districting Adopted Plan Trustee Area 1 Map

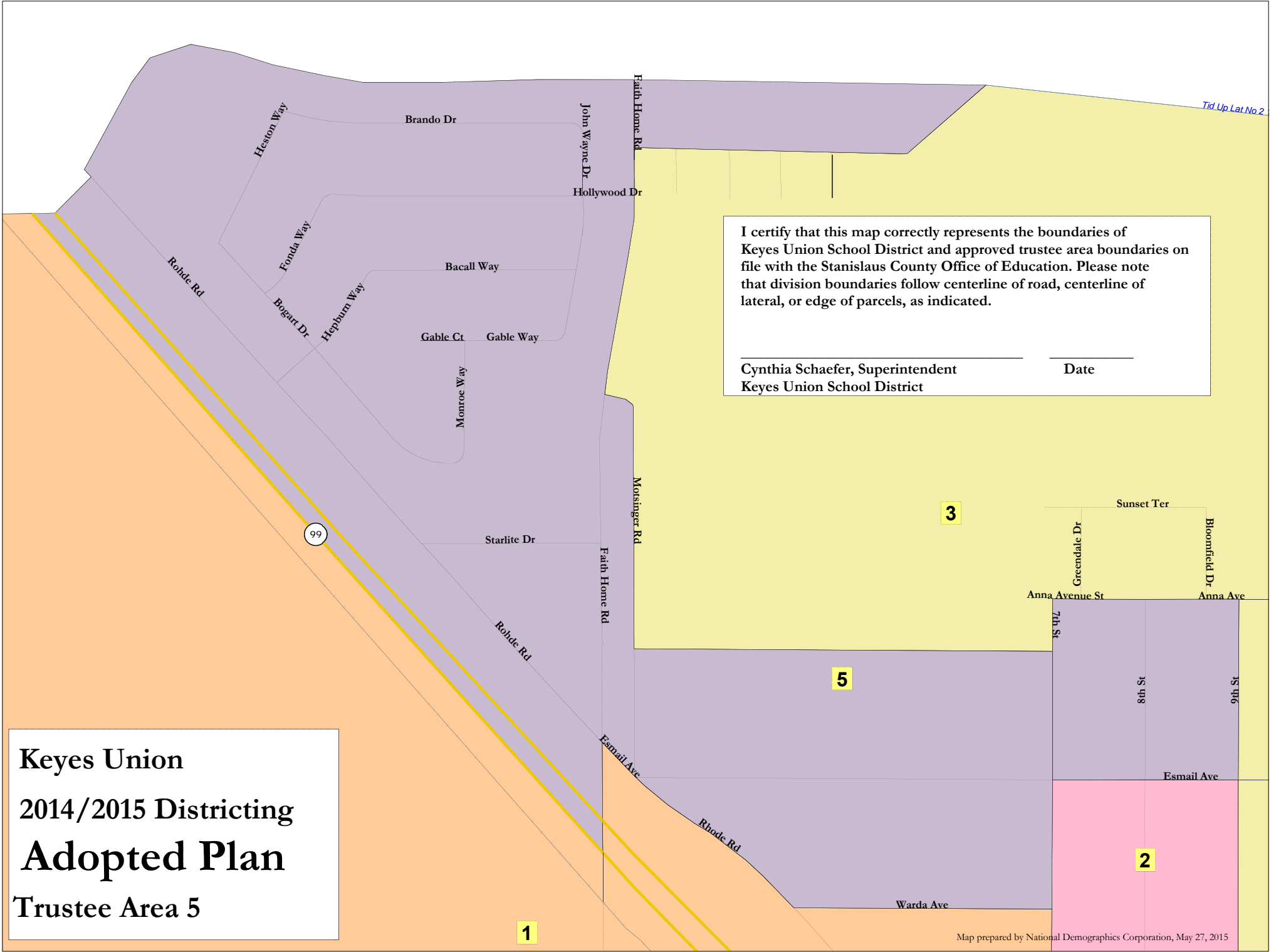

Trustee Area Boundary Description Keyes Union School District

Trustee Area 1

Beginning at the intersection of Highway 99 and the northern border of the District; thence proceeding southeasterly along Highway 99 to Faith Home Rd; thence proceeding northerly along Faith Home Rd to Esmail Ave; thence proceeding southeasterly along Esmail Ave and continuing southeasterly along Rohde Rd to Warda Ave; thence proceeding easterly along Warda Ave to 7th St; thence proceeding southerly along 7th St to Rohde Rd; thence proceeding southeasterly along Rohde Rd to 7th St; thence proceeding southeasterly along 7th St to Nunes Rd; thence proceeding easterly along Nunes Rd to Grace Ave; thence proceeding northeasterly along Grace Ave to 10th St; thence proceeding southeasterly and easterly along 10th St to Horn Way; thence proceeding northerly along Horn Way to Casaba Way; thence proceeding northwesterly along Casaba Way to Stella Ave; thence proceeding northeasterly along Stella Ave to Norma Way; thence proceeding easterly along Norma Way to Washington Rd; thence proceeding southerly along Washington Rd to Nunes Rd; thence proceeding easterly along Nunes Rd and continuing easterly along Keyes Rd to Mountain View Rd; thence proceeding northerly along Mountain View Rd to the District's northern border; thence proceeding clockwise along the District's border back to the point of beginning.

Beginning at the intersection of Warda Ave and 7th St; thence proceeding southerly along 7th St to Rohde Rd; thence proceeding southeasterly along Rohde Rd to 7th St; thence proceeding southeasterly along 7th St to Nunes Rd; thence proceeding easterly along Nunes Rd to Grace Ave; thence proceeding northeasterly along Grace Ave to 10th St; thence proceeding southeasterly and easterly along 10th St to Horn Way; thence proceeding northerly along Horn Way to Casaba Way; thence proceeding northwesterly along Casaba Way to Stella Ave; thence proceeding southwestly along Stella Ave to 10th St; thence proceeding northwesterly along 10th St to Christine Ave; thence proceeding northeasterly along Christine Ave to Dora Ave; thence proceeding easterly along Dora Ave to 10th St; thence proceeding northerly along 10th St to Lucinda Ave; thence proceeding westerly along Lucinda Ave to 9th St; thence proceeding northerly along 9th St to Esmail Ave; thence proceeding westerly along Esmail Ave to 7th St; thence proceeding southerly back to the point of beginning.

Beginning at the intersection of Washington Rd and the District's northern border; thence proceeding southerly along Washington Rd to Lucinda Ave; thence proceeding westerly along Lucinda Ave to Jennie Ave; thence proceeding southerly and southwestly along Jennie Ave to 10th St; thence proceeding northwesterly along 10th St to Christine Ave; thence proceeding northeasterly along Christine Ave to Dora Ave; thence proceeding easterly along Dora Ave to 10th St; thence proceeding northerly along 10th St to Lucinda Ave; thence proceeding westerly along Lucinda Ave to 9th St; thence proceeding northerly along 9th St to Anna Ave; thence proceeding westerly along Anna Ave to 7th St; thence proceeding southerly along 7th St to Anna Ave; thence proceeding westerly along Anna Ave to Motsinger Rd; thence proceeding northerly and westerly along Motsinger Rd to Faith Home Rd; thence proceeding northerly along Faith Home Rd to the unnamed road into Patio Village mobile home park; thence proceeding east along the unnamed road to its dead end; thence proceeding northerly to the District border; thence proceeding clockwise along the District border to the point of beginning.

Beginning at the intersection of Washington Rd and the District's northern border; thence proceeding southerly along Washington Rd to Lucinda Ave; thence proceeding westerly along Lucinda Ave to Jennie Ave; thence proceeding southerly and southwesterly along Jennie Ave to 10th St; thence proceeding southeasterly along 10th St to Stella Ave; thence proceeding northeasterly along Stella Ave to Norma Way; thence proceeding easterly along Norma Way to Washington Rd; thence proceeding southerly along Washington Rd to Nunes Rd; thence proceeding easterly along Nunes Rd and continuing easterly along Keyes Rd to Mountain View Rd; thence proceeding northerly along Mountain View Rd to the District's northern border; thence proceeding counter-clockwise along the District's border to the point of beginning.

Trustee Area 5
